SARS admin penalties for 'late submission' of ITR12

SARS has received a number of referrals regarding the imposition of the Administrative Penalties in respect of persons who have regarded themselves to be provisional taxpayers. The definition of a Provisional Taxpayer in the Fourth Schedule to the Income Tax Act deals with who is classified as a Provisional Taxpayer. From the cases SARS has evaluated where penalties have been imposed, although the persons may have historically been regarded as provisional taxpayers, the facts on the returns as submitted for 2021 clearly indicates that they do not fall within the definition.

It is important to note that the filing and payment of provisional tax is not a criteria for, but a consequence of being a provisional taxpayer as defined.
