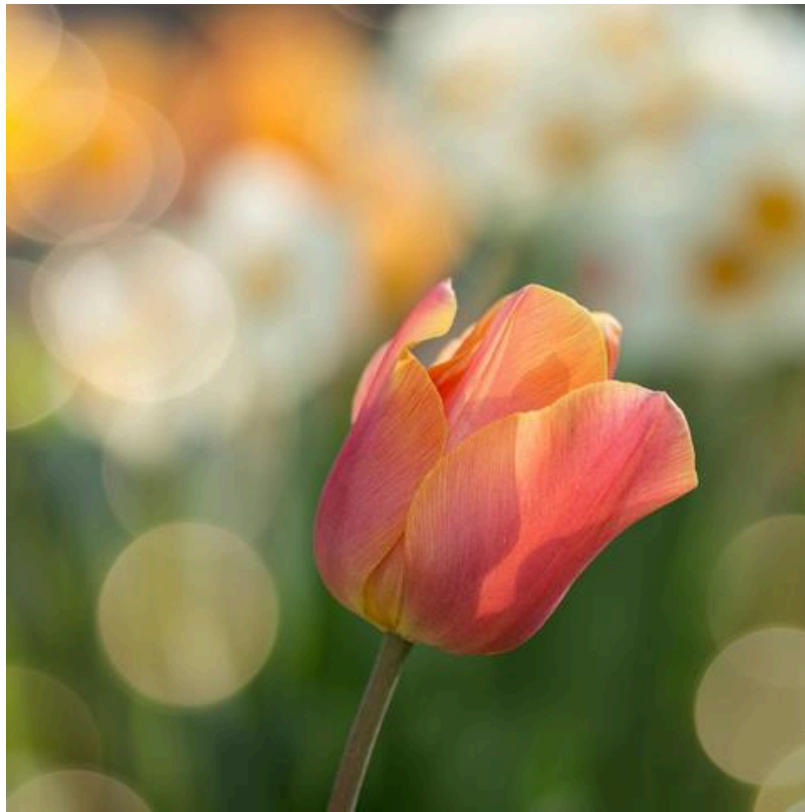
POPIA Notice
