About the IRBA

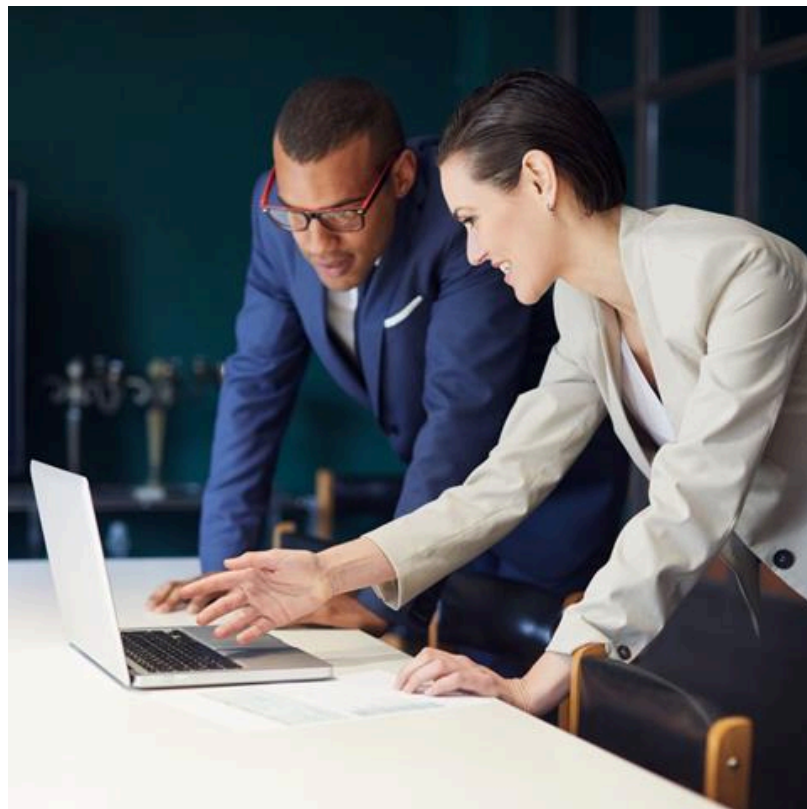

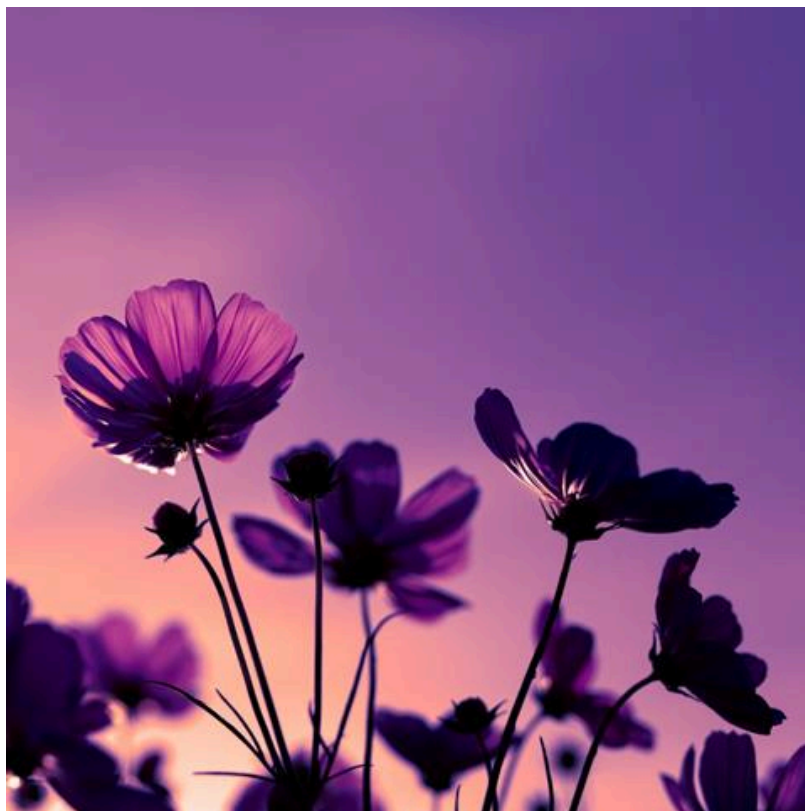
POPIA Notice
